Memorial Hermann The Woodlands Hospital has announced it will renovate and expand its hospital-based Emergency Department to better respond to the emergent needs of the greater Montgomery County area. The \$17.4 million project will include a renovation of the existing space and the addition of approximately 3,400 square feet, bringing the total footprint of the unit to 32,400 square feet.
